PARTICULAR CLAUSES:

-*The contracting party* declares he disposes, without restriction or reserve, of the exploitation rights stated in the present contract.

- *The contracting party* guarantees ZALEA TV against any recourse or action that might be taken on whatever account, whenever ZALEA TV may be exercising those rights, any person or company having participated directly or indirectly in the making of the above mentioned programme.

- *The contracting party* guarantees he holds the release agreement for all the people appearing in the program or to assume eventual consequences.

- *The contracting party* authorises ZALEA TV to quote the organism and the filmmaker(s) in the public announcement of its programming.

- *The contracting party* authorises ZALEA TV to use excerpts of the above-mentioned programmes, announced as such, in -and only in- the presentation trailers of ZALEA TV programmes.
